ABOUT THE COURSE

Healthy Ageing for Impact in the 21st Century aims to give participants the building blocks to become future leaders in the area of ageing. This leaders programme provides participants with the competencies needed to work on this agenda as part of the Decade of Healthy Ageing. The course will begin on 14 September 2020 and run for 14 weeks.

The programme is offered in English, free of charge and is grounded in a unique and innovative e-Didactic format with a focus on teamwork, peer-to-peer feedback, mentorship and project-based collaboration. It operates in a collaborative online environment where participants work as part of a team and receive guidance from a dedicated tutor.

This online course has three primary target audiences: ageing focal points at relevant ministries and local governments, WHO and other UN staff, and staff working in Civil Society Organizations in the field of ageing. At the end of the course, certificates are provided to participants who meet the eligibility criteria. *Participants must have a minimum of working proficiency in English (speak-read-write), be able to commit an estimated 6 hours per week, and be open to working as part of a team.*

By the end of this course, participants should be able to:

- Understand the fundamental concepts of Healthy Ageing and critically apply the knowledge acquired
- Identify challenges and opportunities related to population ageing as well as limitations of existing responses
- Design, together with other peers, an action plan that presents a response to population ageing using the Healthy Ageing public health framework
- Describe the influence that existing attitudes and misconceptions around ageing and older adults (i.e. ageism) can have in the development and effective implementation of policies and programmes on ageing
- Have connections with peers that will help them build the international networks that are needed to achieve impact in policy and practice surrounding Healthy Ageing at scale; and
- Be part of a unique group of global leaders working collectively to develop real-world action plans which aim to resolve challenges to Healthy Ageing
