Privacy and Cookie policy (updated March 2022)

Our website does not collect name and data of people, because we are not interested in profiling visitors. So we can avoid banners required by national and European laws to obtain the user's consent, which waste time and discourage the use of the web.

FORM - The form on the home page for sending messages simply sends an email to the same address indicated in the footer for the convenience of the customer who wants to send a simple short message.

COOKIES - This site uses only technical cookies, namely:

Session cookies that support the editing functions of webmasters pages.

Anonymized technical cookies of third-parties, which cannot collect personal data of users: see details in the descriptions below. They support the services of Youtube, Google Analytics and Google Translate and are activated only when we periodically check the effectiveness of the site.

Other sites linked from our pages may use cookies, but they are not under our control and responsibility.

Youtube

Our Youtube videos have privacy-enhanced mode enabled: therefore YouTube won't store information about our visitors, unless they play the video entering in Youtube. See Google-Youtube guide: https://support.google.com/youtube/answer/171780?hl=en-GB

Google Analytics

In order to detect and optimize site traffic, we use an anonymized version of Google Analytics, which avoids visitor profiling. See https://support.google.com/analytics/answer/2763052?hl=en for more information.

Google Translate cookies

Google Translate sets two third party technical cookies:

googtrans - This cookie stores the translation preference: it contains translation languages, for example '/en/it (English to Italian)', and expires when you close your browser

PREF - The PREF cookie remembers basic preferences, such as the choice of language, the format of the search results, how to view information, etc.: therefore the visitor does not have to set preferences every time he uses the site. It expires after 2 years.

Its structure is similar to this string: "ID = bc7ff7f16d0d774f: TM = 1335534573: LM = 1335534573: S = zPM87avT1rR0zWvi", where ID = browser identifier; TM = date and time of creation of the cookie; LM = date and time of the last modification of the browser preferences; S = digital signature generated by Google that works in conjunction with the page address settings (e.g. In the Google Books site it is used to show only certain pages of the book).

Disabling cookies

To detect and block any type of cookie, we recommend installing Gostery (www.ghostery.com) on your browser. You can also disable cookies by setting your browser option to reject cookies. More information is available at www.aboutcookies.org and:
